Required Educational Qualification: Graduate in Arts, Science or Commerce from a University recognized by the State Government or a degree equivalent thereto and recognized by the Government. The candidates must possess a minimum 6(six) months diploma/Certificate in Computer proficiency from a recognized Institute.

Age and relaxation of age: The candidate should not be less than 18 years and more than 43 years of age on the 1st day of January, 2018. The upper age limit is relaxable by 5 years for SC and ST candidates.

Age limit calculation: The age limit will be calculated on the basis of the Matriculation/HSLC Admit Card Certificate issued by a recognized Board/Council and no other documents shall be accepted in lieu thereof for the purpose.

Mode of Selection:

Phase – I: Candidates, whose applications are accepted as per eligibility criteria, will be required to appear in a written competitive examination. The written examination will be of 250 marks with Multiple Choice Questions (MCQ) for 3:00 hour's duration. Date and Venue of written examination will be notified later by publishing advertisement through daily leading news papers and through district website (http://lakhimpur.nic.in).

Call Letter / Admit Card will be sent to candidates' email id. In case of non receipt of Call Letter / Admit Card through email, candidates are advised to check district website (http://lakhimpur.nic.in) for short listed candidates' list provisionally selected for written test, to check and confirm roll number, venue and date of examination.
